About This Guide

This **Veterans Grant Resource Guide** is intended to be used in conjunction with our more general **Grant Resource Guide**, which contains information about identifying and applying for federal grants.

Each year, 26 federal agencies award federal grants to support community initiatives, research, infrastructure programs, and public interest projects, all relevant to the work and/or goals of that agency. Grants are awarded on a competitive basis or distributed under a formula. The majority of federal grant recipients are state and local government agencies who then distribute funds to smaller entities.

Federal Agencies and Available Grants

U.S. Department of Housing and Urban Development (HUD)

The Department awards discretionary funding through over 20 Grant programs that support specific HUD initiatives, including Affordable Housing Development and Preservation, Community and Economic Development, Environment and Energy, Fair Housing, Homelessness, Homeownership, Rental Assistance, and Supportive Housing and Services.

Tribal HUD-VA Supportive Housing (VASH) Expansion

Current Grants.gov close date: April 22, 2021

Grantees use funding towards rental assistance and supportive services for Native American Veterans who are homeless or at risk of homelessness, living on or near a reservation or other Indian areas. Under Tribal HUD-VASH, Indian Tribes and TDHEs must partner with the Department of Veterans Affairs (VA) to provide case management and supportive services, including healthcare assistance, to eligible Native American Veterans.

U.S. Department of Justice (DOJ)

DOJ offers funding opportunities to support law enforcement and public safety activities in state, local, and tribal jurisdictions; to assist victims of crime; to provide training and technical assistance; to conduct research; and to implement programs that improve the criminal, civil, and juvenile justice systems.

Adult Drug Court and Veterans Treatment Court Discretionary Grant Program

Current Grants.gov close date: March 31, 2021

Through this program, BJA is seeking applications to implement and enhance drug court services, including service coordination, management of drug court participants, and recovery support services. This program provides resources to state, local, and federally recognized tribal governments to enhance drug court programs and systems for nonviolent offenders and veterans with addictions, including stimulant and opioid abuse and overdose.

U.S. Department of Labor (DOL)

DOL's stated mission is to foster, promote, and develop the welfare of the wage earners, job seekers, and retirees of the United States; improve working conditions; advance opportunities for profitable employment; and assure work-related benefits and rights. Through funding opportunities, the Employment and Training Administration (ETA) administers federal government job training and worker dislocation programs, federal grants to states for public employment service programs, and unemployment insurance benefits. These services are primarily provided through state and local workforce development systems

Stand Down (SD) Grants

Current Grants.gov close date: December 31, 2021

A Stand Down is a non-competitive grant that is awarded to organizations to provide basic services to homeless veterans such as showers, haircuts, attention to health concerns, and other collaborative services to give participants a greater sense of self and an opportunity to improve their chances of securing and maintaining employment. Veterans experiencing homelessness do not always have access to basic hygiene supplies that are necessary to maintain their health and appearance. Also, the lack of shelter limits their ability to prepare for and present themselves at job interviews or be contacted for follow-up. These grants funds must be used to enhance employment and training opportunities or to promote the self-sufficiency of homeless veterans through paid work.

U.S. Department of Veterans Affairs (VA)

VA's Homeless Providers Grant and Per Diem Program is offered annually (as funding permits) by the Department of Veterans Affairs Health Care for Homeless Veterans (HCHV) Programs to fund community agencies providing services to homeless Veterans. The purpose is to promote the development and provision of supportive housing and/or supportive services with the goal of helping homeless Veterans achieve residential stability, increase their skill levels and/or income, and obtain greater self-determination.

Grants for Adaptive Sports Programs for Disabled Veterans and Disabled Members of the Armed Forces (Adaptive Sports Grant Program)

Current Grant.gov close date: March 31, 2021

The Adaptive Sports Grant Program provides grants to eligible adaptive sports entities to plan, develop, manage, and implement programs to provide adaptive sports activities for Veterans

and members of the Armed Forces with disabilities. For the purpose of this program, adaptive sports activities include: (1) instruction, participation, and competition in adaptive sports; (2) training and technical assistance to program administrators, coaches, recreation therapists, instructors, VA employees, and other appropriate individuals; (3) coordination, Paralympic classification of athletes, athlete assessment, sport-specific training techniques, program development (including programs at the local level), sports equipment, supplies, program evaluation, and other activities related to the implementation and operation of the program.

The primary goal for this Notice of Funding Opportunity (NOFO) is to ensure that appropriate levels of resources are provided to eligible adaptive sports entities with capabilities that are well-suited to meet the needs and priorities for Veterans with disabilities and members of the Armed Forces with disabilities.

State Veterans Home Construction Grant Program

Current Grant.gov close date: April 15, 2021

Grants are available to State Governments for construction or renovations of State operated Veterans Extended Care Facilities. VA participation may not exceed 65% of the total project costs. Review governing regulation before submitting an application (38 CFR Part 59). If the state is submitting a new grant application, it must submit a complete initial application (Section A of the project checklist) on Grants.gov by April 15th in order to be eligible for listing on the Priority List for the next fiscal year. Once the complete initial application is retrieved from Grants.gov by Program Staff, the grant applicant will receive 1) an automated notification from Grants.gov confirming receipt by the Program and 2) an email from Program Staff indicating the application's FAI number and corresponding project page in MAX.gov for submission of subsequent items.

GPD Special Need Grant

Current Grant.gov close date: May 5, 2021

The VA announces the availability of approximately \$5 million per year for 3 years in special need grants to eligible entities for per diem payments to facilitate housing stabilization for Veterans who are homeless or at risk of becoming homeless and who are in one of the special need populations (i.e., chronically mentally ill, frail elderly, individuals who care for minor dependents, terminally ill, or women). This funding will provide assistance to cover operational costs, including costs that would not otherwise be incurred, but for the fact that the recipient is providing supportive housing beds in private rooms with private bathrooms for a homeless Veteran population with special needs. The funding will allow GPD grantees to continue to transform programs and to meet the challenges local communities face when providing services to certain populations of Veterans experiencing homelessness.

GPD Capital Grant

Current Grant.gov close date: May 25, 2021

Made available via the CARES Act, the purpose of this program to increase safety and reduce the risk to Veterans in GPD transitional housing who otherwise would be experiencing homelessness. Mounting risks posed to vulnerable populations from public health concerns such as the coronavirus and other infectious diseases show a need to increase safety in transitional housing provided by GPD grantees. This funding will 1) allow current GPD grantees to improve the transitional housing they offer to Veterans resulting in less congregate housing and more individual unit style housing; 2) improve personal safety for Veterans, reduce risks associated with close quarters living and increase the availability of individual unit style transitional housing; and 3) allow GPD grantees to continue to transform programs and to meet the challenges local communities face when providing safe spaces for Veterans experiencing homelessness.

Veterans Cemetery Grants

Current Grant.gov close date: July 1, 2021

The Department of Veterans Affairs (VA) Veterans Cemetery Grants Program was established in 1978 to complement VA's National Cemetery Administration. The program assists states, territories and federally recognized tribal governments in providing gravesites for Veterans in those areas where VA's national cemeteries cannot fully satisfy their burial needs. Grants may be used only for the purpose of establishing, expanding or improving Veterans cemeteries that are owned and operated by a state, federally recognized tribal government, or U.S. territory. Aid can be granted only to states, federally recognized tribal government, or U.S. territories. VA cannot provide grants to private organizations, counties, cities or other government agencies.

VA can now provide up to 100 percent of the development cost for an approved project. For establishment of new cemeteries, VA can provide for operating equipment. VA does not provide for acquisition of land. The value of the land cannot be considered as an "allowable cost" under the grant. States, territories and tribal governments are solely responsible for acquisition of the necessary land. Tribal governments cemeteries must be on tribal trust land.

The Small Business Act provides for entrepreneurial training, business development assistance, counseling, and management assistance to small business owned and controlled by eligible veterans, as well as the authority to make grants to, and enter into contracts and cooperative agreements with education institutions, private businesses, veterans' nonprofit community-based organizations, and federal, state, local, and tribal government agencies for the establishment of and implementation of outreach programs for veterans and service-disabled veterans.
